

**The Women's Fund of Greater Chattanooga (WFGC) 2023
Nightingale Network Grant Application**

Mission: The Women's Fund of Greater Chattanooga leverages **advocacy**, education, and empowered **philanthropy** through strategic grantmaking, and a robust **network** of collaborative partnerships to address the root causes of inequity and to create lasting change for the women of the Chattanooga area and the state of Tennessee.

About the Nightingale Network: The Nightingale Network is the collective philanthropy arm of the Women's Fund. They are a group of like-minded individuals working together to have a positive social impact on our community. 100% of Nightingale Network membership fees and matching gifts are used to fund an annual grant to a community organization that is ultimately selected by a vote of the membership. Since 2011 the Nightingale Network grants have awarded more than \$120,000 to area nonprofits.

The 2023 Nightingale Network Grant will fund an effort elevating the status of women in one of the following areas. *(For your reference, more information on each on these impact areas and the IWPR's Status of Women report that ranked Tennessee as 49th in the Status of Women can be found at <https://statusofwomendata.org/explore-the-data/state-data/tennessee/>*

Priorities The WFGC welcomes proposals from organizations, individuals, and/or programs that are committed to creating long-term social change for women and/or girls that:

- Promote gender, racial, economic and social justice;
- Increase the economic success of marginalized populations;
- Emphasize community organizing and/or advocacy strategies in order to create meaningful institutional change in their communities; and
- Are diverse and inclusive.

Funding Eligibility

- Programs must benefit women and/or girls in the Greater Chattanooga area.
- Funded work must take place between November 1, 2023 and October 31, 2024.
- Individuals and organizations without 501(c)(3) status are eligible to apply, **however, they must have a 501(c)(3) fiscal agent to receive the grant.** *You can find more information about securing a fiscal agent on the [Fiscal Agent FAQ and Resources Document on our website](#).* The benefit of a grant from the Women's Fund must reach beyond the individuals or organizations applying.

Size of Grant Award Our goal is to grant \$10,000 (\$5,000 raised through Nightingale Network membership fees + matching donor up to \$5,000)

Use of funds: Grant funds must be used to carry out the program, effort, or initiative described in the grant proposal.

Funding Restrictions The WFGC will not fund projects that discriminate on the basis of ethnicity, race, color, creed, religion, national origin, age, disability, marital status, sexual orientation, gender identity or expression, HIV/AIDS status, veteran status, or any economic circumstances.

The WFGC will not fund projects that present or incorporate religion in any manner. While there is no restriction on funding faith-based organizations, all projects and services that are funded by the WFGC must be secular.

Funds May Not Be used for:

- Political campaigns or promotion of candidates for public office
- Capital or endowment campaigns

Your Commitment: we expect that grantees will:

- Fully engage in all meetings, interview & collateral requests related to the grant making process.
- Attend our annual luncheon, Voices, on September 29, 2023, to receive the check or substitute presentation event depending on the status of social distancing guidelines.
- Present your progress and the impact of the grant funds at our May 2024 Nightingale Network Event event using data, pictures, and anecdotal evidence as appropriate to show the success of your project for WFGC.

Grantmaking Process: Completed applications are due by 5:00 p.m. EST June 22, 2023. All eligible applications will be reviewed and scored by the Nightingale Network Committee. The Committee will select and present three grantee finalists to the Board of the Women's Fund for approval. Grantee finalists will be notified no later than August 1, 2023; the three grantee finalists must present their proposals at the Nightingale Voting Launch Event on September 13, 2023. Each member of the Nightingale Network is entitled to one (1) vote, and the finalist with the most votes will win the grant. The recipient of funding will be notified no later than September 22, 2023. The 2023 Nightingale Network grant recipient will not be eligible to apply for the grant again for two years. 2023 Nightingale Network finalists will not be eligible to apply for the grant again for one year after they were chosen as a finalist.
